Managed Detection & Response - CERT

The SOC team together with the Incident Response Team form the **Innovery CERT (CERT-INN)** through which **reactive and proactive defense services delivered by T1 and T2 level analysts** are offered, and at the **T3 analyst** level advanced proactive defense services are delivered too, also aimed in collaboration with technology partners and other national and foreign CERTs.

Defensive Security



Division that deals with the **prevention**, **detection and supply of correct and prompt answers to cyber attacks and threats**, thus guaranteeing the safety of corporate infrastructures and information, the defense of the IT network that includes response to actions, the protection of the critical infrastructures and the guarantee of information for organizations, governmental authorities and other possible networks.

Offensive Security



It provides an **assessment of the security and exposure of IT systems of a company,** in order to define the appropriate countermeasures. The security assessments are based on: Vulnerability Assessment, which through automatic scans aim to discover all the vulnerabilities present in the systems; Penetration Testing, a process where the real existence of vulnerabilities in systems and the impact they may have are manually validated. Vulnerability assessments can be carried out on networks, web-based applications, mobile applications, IoT devices, SCADA environments. This division in Innovery also deals with advanced security services such as Disaster Simulation, Digital Risk Assessment, Team-Oriented Security Testing, RTT, TTPs, and PTT.

Advisory




